-Creating a caring culture is key to engaging all learners.


-Everyone takes personal responsibility for achieving targeted results.

What is a Charter System?

Definition

- A local district has a performance contract with the SBOE granting it all allowable waivers from Title 20 provisions, SBOE rules, and GaDOE guidelines.
- Although charter systems are granted a broad flexibility waiver, the application requires a list of waivers the district needs to implement its strategic plan.

Facts and Features

- The performance contract is between the District and the SBOE.
- The District gains flexibility to innovate in exchange for increased academic accountability.
- There is a distributed leadership process- including local school governance councils for each school.

Advantages...

• Flexibility to innovate

- Financial savings from waivers
- Additional per-pupil funding in QBE IF appropriated.

School level Governance


=New and exciting initiatives like STEAM, non-graded, seat time, etc.

- =Flexible pay schedules for NEW employees
- =Not counting on this...but the status may make us eligible for more state and federal grants!

• =Increased ownership, buy in and accountability at the school level.

Consequences/Accountability

- Probationary status
- Early termination or nonrenewal of the performance contract.



Facts and Figures as of December 2014

• There were 28 Charter Systems in Georgia.

• There were 22 letters of intent for Charter System Status



How did we derive at the decision to become a Charter System?

- Several years ago, the Georgia Legislature passed a law that required school systems to make one of the following decisions: IE2, Charter System, System of Charter Schools, or Status Quo.
- ALL school systems must make a declaration/decision by June 30, 2015.
- Jasper County Schools: Dr. Newton reviewed and studied all flexibility options with the BOE, CCT, and various advisory groups during the FY13-14 school year.
- During the summer and fall of 2014, a community conversation and various focus groups met to discuss the future direction of Jasper County Schools.

- During the fall of 2014, the GaDOE revised some of the accountability option details.
- Fall 2014: Dr. Newton attended several DOE updates at RESA and at several conferences.
- Dr. Newton, Ms. Edge, Ms. Burrell, and Dr. Fendley attended a Charter System workshop in January 2015.
- Dr. Newton reviewed the flexibility changes with the Board.
- Dr. Newton recommended the Board choose the Charter System option in February 2015.

What are the next steps in the Charter System process?

- The District Leadership Teams (CCT, BST) will meet this summer (July 22-23) to develop a comprehensive framework for our charter (i.e. Revamp the District CIP).
- Board of Education and other community stakeholders will be included in this summer planning meeting.
- FY 15-16: The CCT will work in collaboration with BSTs and School Councils to complete a comprehensive district strategic plan that includes the required Charter System Components.
- The plan will also include Jasper County's signature focus that is aligned with OUR vision and mission (which will likely be revised).
- We hope to align the new Charter System Plan with our AdvancEd renewal.



Questions to consider as we redesign....

- What is our district's strategic plan?
- What are our areas of needed improvement?
- What evidence exists that these areas are challenges for your district?
- What actions will your district take to address these challenges?
- What research do you have that these actions will be effective?
- What Georgia laws or DOE rules will you need to waive in order to implement your actions?
- What is the timeline for your actions?
