- Mr. Schilling called the meeting to order and welcomed all present.
- The agenda was amended with a section to render the board decision on a student disciplinary appeal.
- The Board of Education approved a motion to enter into executive session.
- The Board of Education approved a motion to exit executive session.
- The Board of Education approved a motion to modify the punishment originally provided by the Student Discipline Tribunal.
- The Board of Education approved to adjourn the meeting at 6:09 PM.

- Mr. Schilling called the meeting to order and welcomed all present.
- The agenda was approved as presented.
- Opening ceremonies were held.
- Mr. Garland led the Board and audience in the reading of the mission and vision statement.
- There were no public comments.
- Mr. Garland provided a COVID-19 update. Three students and one employee have been confirmed with COVID-19 since the last reporting in October.

- Mr. Garland noted an increase of 33 FTE during the October 2021 reporting cycle as compared to the March 2021 reporting cycle. He thanked Dr. Susan Stone, Cara Bockholt and clerical personnel at all schools in gathering the information for the bi-annual reporting to the state. He noted the increase should provide additional funding for the system from the state level.
- Dr. Barton gave a facilities subcommittee update.
- The Board approved a bid for \$10,500 to repair the roof at the bus garage.
- The October 2021 Financial Report was presented. For the 1<sup>st</sup> 3<sup>rd</sup> of the year, revenues have exceeded expenditures by 4.97%.
- The Board approved the SPLOST schedule to run in the local paper December 2 and December 9.
- The Board approved the surplus of 65 laboratory stools at \$10 per stool with a method of distribution of first come/first serve.
- The Board approved amendment #1 to the American Rescue Plan Act
- The Board approved the purchase of 34 interactive panels for Jasper County High School at a cost of \$153,658.99 from Micro Technology Consultants.
- The Board approved the Amended and Restated Intergovernmental Contract Revenue Sharing Agreement for Stanton Springs North and Stanton Springs. The school system shall receive 40% of all proceeds applied to Jasper County while county government will receive the remaining 60%.
